Sharing of commercials: 2500/- of the total collections to ATS Global – 500/- to SFS Degree College.

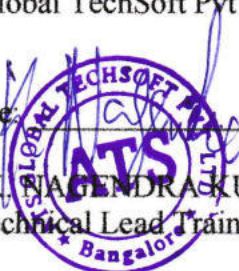
- Only after the total Payment is received from the enrolled students. ATS will issue the cheque for the same.
