The IQAC of SFS College had organized a Workshop on New NAAC Framework of 2022. This three days workshop was organized in view of providing a detailed insight on the new framework of NAAC released in the month of January 2022. Resource persons from Kristu Jayanti College were the resource persons. Since Kristu Jayanti was accredited with A++ in their last cycle of accreditation, IQAC discerned that it was appropriate to foregather their expertise to facilitate us in the preparation for the next cycle of accreditation.

The workshop started on 21 September 2022. The AAA Core Team attended the meeting along with the Management, Academic Coordinators, IQAC and AAA Coordinators. The resource person of this day were Prof.Ramya and Dr.Manikandan. Prof.Ramya, with her vast experience as a core member of IQAC started the session with her presentation on the New NAAC Framework. Starting from the importance and process of accreditation, she dealt with the changes made by NAAC in QIF. After a detailed session on the new manual, Prof.Ramya discussed the 6<sup>th</sup> Criterion – Governance, Leadership and Management. She deftly explained the thrust areas of the criterion, i.e. decentralization, participative management, faculty welfare measures, deployment etc. In the presence of Management during the session, Dr.Manikandan also gave many suggestions about the


annual strategic plan meetings, very crucial to be held during the beginning of every academic year. The day's session came to a close at 4.30 pm with a note of thanks by Dr.Tharini.P


Dr.Justin Nelson Michael and Dr.Aruna Devi were the resource persons for Day 2. On this day, criteria 1, 2, and 3 was discussed. The session started with the presentation by Dr.Aruna Devi. She is an expert academician and has helped institution with documenting teaching and learning outcome. Dr.Aruna deciphered the metrics of criterion 1 and 2. Since these two are the major criteria concerning academics, this was dealt in detail. Teaching, Learning and Evaluation, criterion 2 with a weightage of 350 marks is the heart of NAAC process. She also explained various experiential learning or student centric teaching methods. Talking about the qualitative metrics in the criteria, she spoke about what additional information can be furnished for it. Criterion 3 – Research, Innovation and Extension details was addressed by Dr.Justin. Being an expert in the field of research, he highlighted that research determines the future of HEIs. Research is the prime focus in India and UGC also recommends the same to ensure a healthy research environment. Dr.Justin suggested to facilitate a conducive atmosphere for research and insisted that the college should take up international collaborations. An institution's inclination towards service to society should be achieved through the students of HEI. To ensure this, 100% students' participation is important towards extension and outreach programs, was mentioned by the resource person.

Day 3 of the workshop also had two resource persons from KJC, Dr.Priya and Ms.Mary Jacob. Talking about criteria 4,5, and 7, the resource persons spoke about ICT facilities offered in college, library resources etc. They mentioned that the most difficult aspect of NAAC is to gather data related to student placement or enrollment to higher education. They also discussed the importance of well-defined audit statements to substantiate the expenditure made towards various aspects like infrastructure, maintenance, purchases etc. They put forth the importance of students' participation in cultural/sports events at national and international level. Criteria 7 involving many green initiatives and audits which needs more awareness in the staff and students. It helps in identifying the possibilities of the institution to contribute towards environment and sustainability. Dr.Priya discussed about the process of identifying the best practice and distinctiveness of the institution. The NAAC recommends a process of documenting the outcome of best practice. A lot of ideas evolved during the sessions and it gave a immense clarity on the methodology of working and documentation.
