A REPORT ON

NATIONAL CONFERENCE ON RESEARCH AND IPR

Date: 14 and 15 June 2018

Venue: Auditorium

The Research and Intellectual Property (IP) Cell of St Francis College, Electronic City, Bangalore conducted a National Conference on "Research and IPR" on 14 and 15 June 2018. Dr. Venkateshwaran, Prof. of English (Retd.), Regional Institute of English, South India, was the Chief Guest of the Event. Syed Sikander Ali, Senior Engineer (Research and Development) at Cisco Systems, Bangalore was the keynote speaker. The other dignitaries present on the occasion were Prof. Achuta Jois, Chairman and Director at Atma and Acliv Group and Mr. Mohsin Ali, Senior Advocate. Dr. Nebula, Convener of Research and IP Cell, welcomed the gathering. The Seminar was divided into three technical sessions followed by paper presentations.

Day 1: I Technical Session

Prof. Pramila Mohanty, Professor of Computer Science, Department of MCA, AMC Engineering College, Bangalore chaired the first technical session. She raised various vital issues and concerns related to research and IPR. She touched upon the issue of protecting intellectual property through copy rights and patents. She gave an insight into the various ways of protecting one's research and she also touched upon the licensing process in India. Her speech was followed by the presentation of research papers.



Day 2: II Technical Session

The speaker of the 2nd technical session was Mr. Mohsin Ali, Senior Advocate, he gave an overview of the Intellectual Property Laws in India. He spoke about the laws on copyrights infringement and delved on the legal remedies available in India to protect IP. He briefed on the laws related to copyrights, trademarks, patents, industrial design, and domain names rights. It was followed by paper presentation by delegates. III Technical Session

The third technical session commenced with the input session by Dr Achuta Jois, Chairman and Director at Atma and Acliv Group. He spoke on copyright and patent systems in India and how Research and Development work that is highly susceptible to infringement can be protected through patents and copyrights. His speech was followed by presentation of papers by the delegates.

There were total 32 participants out of which 14 participants presented their paper. The delegates have taken significant inputs out of this seminar which include understanding IPR and its relationship with research and development. They learnt about laws related to IPR and the copyrights and patenting process.

This seminar on IPR created great awareness about the important concepts related to IPR, copyrights and patent issues. The students, research scholars and faculty from different colleges immensely benefitted from this seminar.


