MEMORANDUM OF UNDERSTANDING


This Memorandum of Understanding is made on this 26th day of JULY 2021 by and BETWEEN PALOMA PU COLLEGE, run by PALOMA FOUNDATION (first party) Hereinafter referred to as "First-party" and ST. FRANCIS DE SALES COLLEGE (second party) Hereinafter referred to as "Second-party".

PALOMA PU COLLEGE, run by PALOMA FOUNDATION represented by **Mrs. Reena Anjaria** the Secretary and **Mrs. Umadevi Patil** the Principal of Paloma PU College who will oversee the process of recruiting students from Paloma PU college for the UG courses conducted in St. Francis De Sales College, Electronic city, Bangalore-100. The admission process & the fee details will be shared with **Mrs Umadevi Patil** in advance for the smooth admission process.

The First party has to ensure the following while extending its service to the **Second party**:

- Ensure the students fit the eligibility criteria as per the Bangalore University and the College for the UG courses.
- Ensure to complete the process of admissions as per the date given by the College.
- Ensure the original documents of the candidates are submitted to confirm the admissions as per the Bangalore University and the College requirements.
- Ensure the students are told clearly about the fees & all the upcoming charges (University exam fees, uniform fees, non-Karnataka board fees etc...) and fees once paid will not be refunded, even if the student cancels the admission.
- Ensure that the college is able to maintain contact with parents/guardian through mobile/email. Be available to assist the college for any needs related to those students recruited by you.

1. The Agreement is valid for 'One Year' from June 2021 to June 2022 and could be renewed every year thereafter with mutual consent.
2. 50% of the college fees of the selected number of students approved by the Secretary and the Principal of Paloma PU College will be paid by PALOMA FOUNDATION every year, while the other 50% of the fees will be paid by the students themselves. Students who join from Paloma PU College will be given a scholarship as per the slab given below.
3. Either of the parties will have the right to withdraw from the agreement by giving 60 days' notice
4. The process of admission for UG will include the counselling/written test for the course as well. **Fees paid at the time of admission will not be refunded at any circumstances.**
5. Payment of scholarship will be made to the students by the Second Party as per the slab given below, if all the conditions of this agreement are fulfilled as per this agreement.
