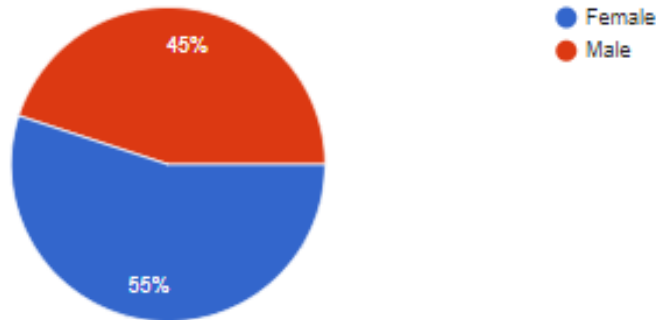

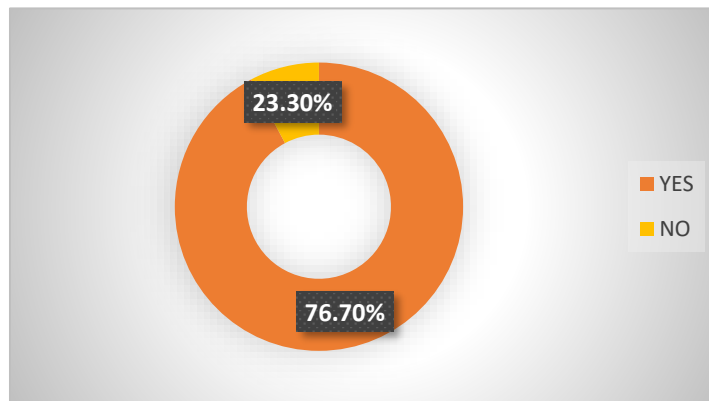
ANALYSIS

Analysis : Out of 1147 respondents, 55% of the students Identified as females and 45% of the students identified as male.

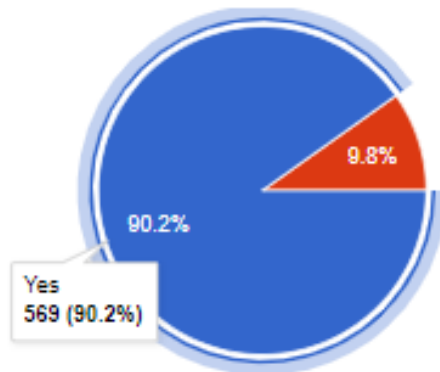
Q4. The Institution organizes Gender Awareness programs



Analysis : 76.7% of the students have commented that the Institution organizes awareness session and 23.3% of the students failed to attend the awareness sessions.

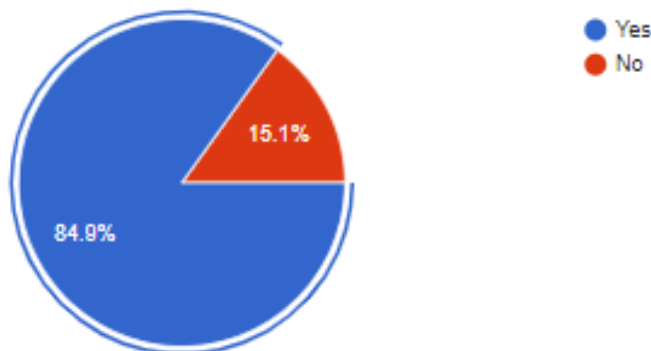


Q5. The sessions/ workshops organized by the Institution creates awareness, instils the employability and builds leadership quality.



Analysis : As per the data Given 90.2% of the students said that the sessions and workshops instils employability and builds leadership Quality among them.

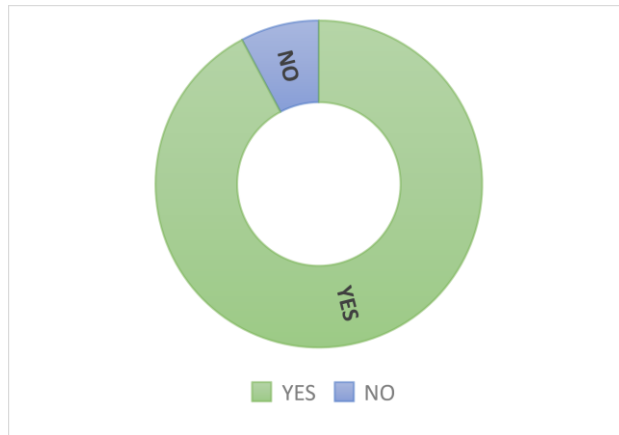
Q6. A Grievance Cell has been set up by the Institution.



Analysis : As per the respondents data Given 84.9% of the students agrees that there is Grievance Cell in the Institution and 15.1% of the students are not aware.

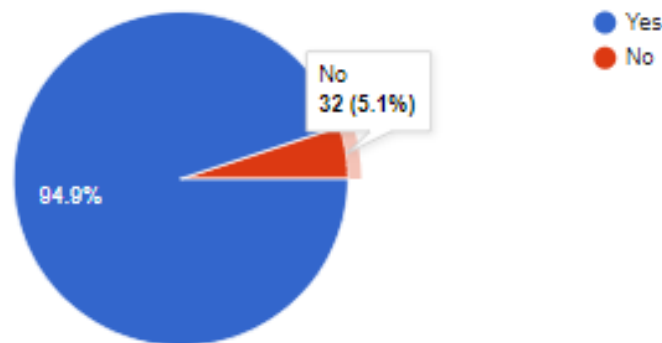


Q7. There are adequate number of toilets available in the College Campus

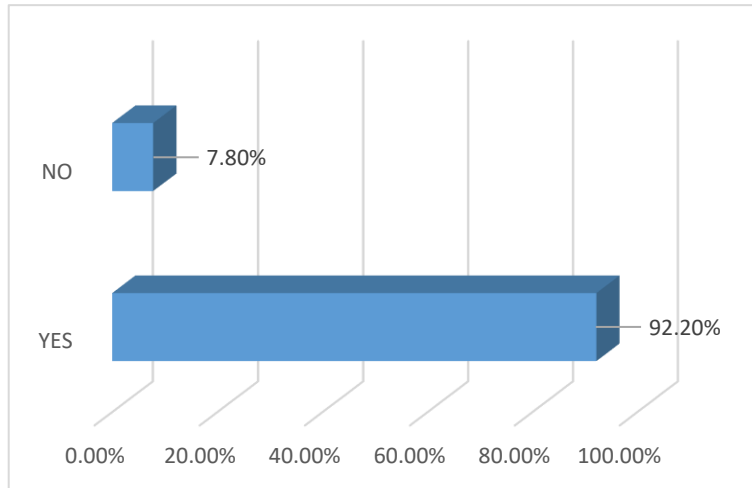
Q8. There are adequate disposable bins available in the toilets



Analysis: As per the data 94.9% of the students are happy and says that there are adequate Disposable bins available in the Toilets.

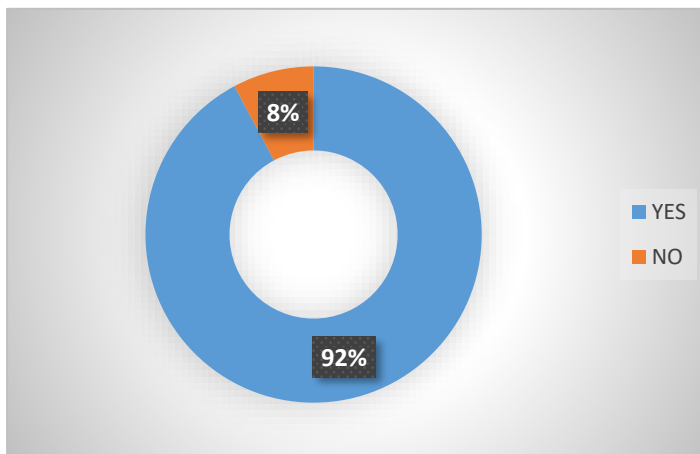


Q9. Effective guidance can be availed from the Counselling Cell (Counselling Centre)

Analysis : Out of the Respondents 81% of the students agrees that there is a on time availability of the Nurse and first Aid Kit. 19% of the students are not availed it on time.

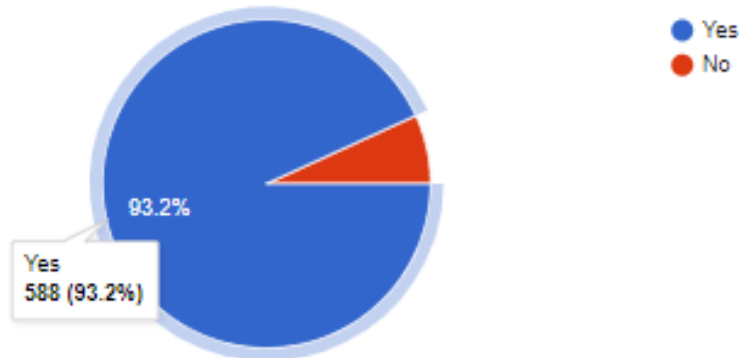

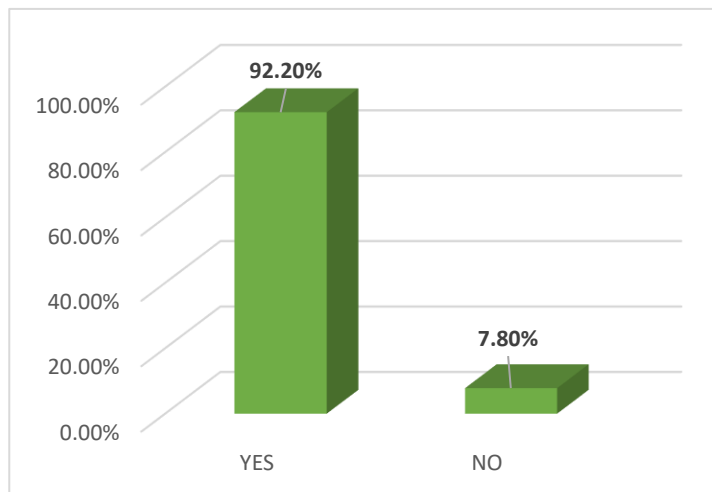

Analysis: Out of the Respondents data received, 94.30% of the students have agreed that campus creates an inclusive environment for spots and development.

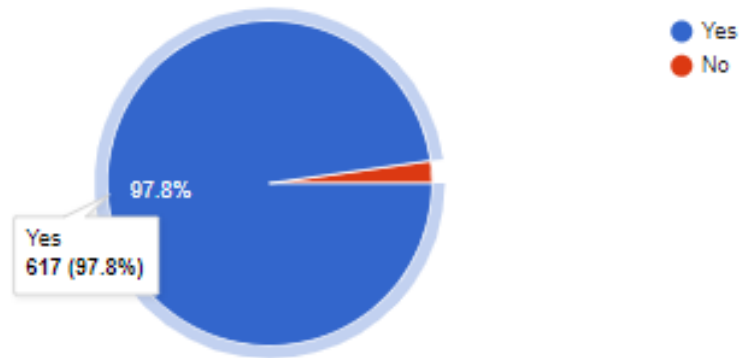

FINDINGS :

- Students shall be given awareness sessions on the Counselling cell facility provided in the campus.
- Students should be able to get on Campus Nurse and First Aid Kit on time.
- To promote responsible waste management practices, reduce littering, and create cleaner and more sustainable common spaces.

RECOMMENDATIONS/ SUGGESTIONS :

- Vending machines for disposable bins could be designed with sustainability in mind. They could be made from recyclable materials and include separate compartments for different types of waste, facilitating recycling and waste segregation. Educate and raise awareness about the importance of proper waste disposal.
- Gender Awareness programs should be conducted More in numbers besides including a subject the curriculum as Open Elective.
- It's essential for students to be aware of the existence of a grievance cell and who is in charge of it to ensure they have access to the necessary support and resources. Establish clear communication channels to inform students about the grievance cell and its responsibilities.
